## The Hearth Tax in Levens

Transcriptions of the 1670 and 1674 assessments

## **Background Information**

The transcriptions of the 1670 and 1674 Heath Tax assessments for Levens, shown below, are taken from Colin Phillips, Catherine Ferguson and Andrew Wareham, *Westmorland Hearth Tax*, The British Record Society, Hearth Tax Series, Volume VI and Cumberland and Westmorland Antiquarian and Archaeological Society, Record Series, Volume XIX, 2008.

The first Act, which received royal assent on 19 May 1662, stated that from and after March 25th, 1662, every -dwelling house shall be chargeable with the annual payment of two shillings for every fire-hearth and stove within such house, to be paid yearly at Michaelmas (29 September) and Lady Day (25 March) in equal proportions, the first payment to be made at Michaelmas, 1662. The only persons who were exempt from this tax were the poor, i.e., those inhabiting houses of a value less than twenty shillings per annum and were certified as such by the Minister and Churchwardens for their parish, also those persons owning blowing houses and stamp furnaces or kilns, or any private oven, and for the hearths or stoves within Hospitals or Almshouses for the poor, whose net amount of income did not exceed £100 per annum.

The system failed to bring in the anticipated revenue, and this was perceived as being due to the local constables, the first collectors, who were too lenient in their duties. The Act was therefore amended in 1663, when the constables were obliged to check the householders' own return, and again in 1664, when collectors were appointed by the King to collect the revenue. The King's collectors were further empowered to inspect dwellings to ascertain the number of hearths with a view to detecting cases of evasion. Throughout its 27 years of operation, the tax was much resented and resisted by all classes, so that William III, shortly after his accession, sent a message to the House of Commons expressing his willingness to have the tax removed. Consequently in April, 1689, the Act was repealed, and the tax ceased to be collected on the ground that it was oppressive to certain classes, and an offensive and distasteful form of imposition upon the public generally, who had to submit to their houses being entered and searched at pleasure by persons frequently unknown to them.
